1. Campers and parents agree to abide by rules and regulations set by Directors for health, safety and welfare of campers.
2. Camp is not responsible for camper's equipment or personal belongings, while in transit or at camp, if lost or damaged by fire, theft or otherwise. Camp will make every effort to provide proper supervision so that losses will be at a minimum.
3. Directors reserve the right to deny, cancel, sever or suspend a child's enrollment if deemed for the best interest of the camper or the camp, in which case the deposit or unused camp fee will be refunded. Refunds are not provided on a per diem basis.
4. Fees: The weekly fee for camp is \$230 for the first child in each family, and \$210 for second child, \$50 per additional child. Partial weeks are allowed, with fixed day selections, such as every Tuesday & Wednesday, for \$60/day/camper, and half-days are available for \$30 either 8 AM-noon or noon-4 PM. We also offer early drop off from 7 AM and late pickup until 6 PM. Please see "Camper Schedule Form" for camper scheduling.
5. Campers who participate in Swimming and Diving teams must also pay the associated swim team fees.
6. Deposits: A deposit of the fees for the last week of the camp should be paid by May 15 to hold the campers position.
7. An allowance will be made for interruption in the camp season due to adjustments to the Cherry Hill Public School calendar. Partial week campers may elect to switch days with prior notice. Please inform the camp director as soon as possible of schedule changes. There is a \$25.00 fee for returned checks. BFSC Day Camp qualifies for Dependent Care Flexible Spending Account (FSA) reimbursement.
8. Health forms, camp application, camp enrollment agreement, and camper schedules are due June 1st. Campers are not permitted to attend until all forms are submitted.
9. Parent's signature gives camper permission to participate in all camp activities shown on sample and final schedule, special programs and off-site trips, etc. I understand that part of the camping experience involves activities, group arrangements and interactions that may be new to my child. These things come with certain risks and uncertainties beyond what my child may be used to dealing with at home. I am aware of these risks, and I am assuming them on behalf of my child. I realize that no environment is risk-free and so I have instructed my child on the importance of abiding by the camp's rules. My child and I both agree that he or she is familiar with these rules and will obey them.
10. Parent's signature further gives camp permission to use camper's likeness or image in camp publications, web site and videos.
